

Eleven Are on Bond to Appear Before Federal Grand Jury

The eleven alleged bootleggers whose realms were invaded yesterday afternoon by 25 government raiders were out on bond today lamenting the fact that they permitted two ultra-col-legiate lads to be included in their clientele.

United States Commisisoner Jack Williams of Danville, who also acts as a special correspondent for the Danville Commercial News, held court in the premises of Police Magistrate George James until 5:30 o'clock yesterday afternoon and when the session had ended eleven of the alleged kings and members of their courts had been released on bonds ranging from \$500 to \$25000, to assure their appearance before a federal grand jury in Danville on September 11.

While the alleged bootleggers paraded before Commissioner Williams, the two collegians, Eliot Ness and Sidney Kennedy sat close by, standing up occasionally before the commissioner to swear to a warrant or to testify to a point of evidence necessary to hold the defendants to the grand jury. It was the work of the two college boys which caused the federal agents to descend upon the Twin Cities.

Ness, wearing the official pin of Sigma Alpha Epsilon, one of the most prominent national fraternities, and dressed in clothes that would do credit to the most representative men on the Illinois campus, was the master mind of the affair. Kennedy was much less the collegiate of the two, not having mastered the art of getting the right twist on a striped bow tie.

The two were selected as special agents three weeks ago by Prohibition Director Yellowley's office and told to secure evidence on the bootleggers in the Twin Cities. Having graduated from the University of Chicago, Ness was well fitted for the job.

(By United Press) New Berlin, Ill., May 26.—Mrs, Dolly Flatt, 45, housekeeper on the Harold Knudson farm two miles from here who was struck on the head with an axe last evening, is not expected to live thru the day, attendants at a Springfield hospital said today. armed posse is searching the neigh-borhood for Lames rrayes, 25, farm hand who is charged with at attack.

Hayes, discharged from the farm after Mary Flatt, 12 year old daughter of the injured woman, complained of his unwelcome attentions, is said to have returned to the farm, where he battered down the door to the room in which the mother and her daughter were hiding and threatened them with an axe. The daughter fied according to her slory, but the moth er tripped over a screen in the back yard and was set upon by Hayes. A deep gash was cut in her skull and the axe was found nearby.

The girl told authorities that Hayes had assaulted her yesterday morning in a garage on the farm. She did not tell her mother of this, she said, mere ly complaining of his attention and

asking for his discharge.

Stayed at Coilege Hall Locating at College Hall on East Green street, and whirling about the campus in a Jordan eight, the two sleuths had little trouble getting evidence. "Smitty" who Director Modelar said "Smitty,' who Director Madden said was the real king of all local bootleggers, was bedfast when the dry raiders broke into his house at 304 South Sixth street. None too sturdy to begin with, "Smitty" has been seriously ill for the past week suffering with ulcers of the stomach and Pete Griffith, his good man Friday, has been tending to the business. Griffith was nabled and charges of sale transpornabbed and charges of sale, transportation and possession were addeed against him. "Smitty" was barely able to appear before Commissioner Williams in police court, and seemed relieved when bond was furnished and reneved when bond was furnished and he was allowed to return to bed.

The biggest liquor haul of the day was made at the Spencer Johnson place, where 200 gallons of whisky mash, which would have been turned into 100 gallons of \$10 a quart whiskey in a few days, was taken by officers. Small quantities of other liquor also adorned the collection of evidence also adorned the collection of evidence produced against the Johnsons who were out of town when the raid was made. who was in Mrs. Catherine Gray, charge of the place, declared emphatically yesterday that she was the victim of hard luck. "I don't run the place," the portly colored woman said. "They just left me with the keys and went to Chicago." Mrs. Gray was relessed on \$1,000 bond after she had charged with possession. Mrs. Cora; Sauter, 203 North Fifth street, who told Commissioner Williams-vesterday that she took in washings and was too respectable to bootleg, was bound over to the grand jury under \$2,000 bond which was signed by T. T. Taggert. Charges of selling liquor were lodged against the Sauter woman by Ness and Kennedy who alleged that they purchased a pint of alcohol from her last Saturday night.

The two business houses in Champaign which were raided—the Hamilof alcohol were found at the Hagen place by raiders. No liquor was found at the Hamilton Snyder resort, but the collegiate Kennedy lestified that he had bought a half pint of alcohol there last Saturday night.

Six negroes who were caught at the Whitfield Thomas place were released but the proprietor, Abe Harris, was held to the grand jury under \$2,000
