3. Interrogatory: Number of rooms originally designed for use as classrooms and actually being used for elementary grade classrooms:

4. Interrogatory: Number of rooms originally designed for use as elementary grade classrooms and now being used for other educational purposes. (including branches of high schools)? (Indicate what these rooms are used for.)

Answer: No classrooms in Bond, Burnside, Cornell, Dixon, Gregory, Kipling or Parker are currently being used for other educational purposes (including branches of high schools).

5. Interrogatory: Number of rooms originally designed for use as classrooms and NOT currently being used?

Answer: There are no classrooms in Bond, Burnside, Cornell, Dixon, Gregory, Kipling or Parker presently designed for use as classrooms and not currently being used.

6. Interrogatory: Number of rooms which have been converted to or used as classrooms?

A. What were these rooms originally used or designed for?

B. Do these rooms, as converted and used, meet current fire and health standards?

C. How many rooms in the basement are used for classrooms?

Answer: The library at Burnside and Dixon is being used as a classroom. Two ground floor rooms at Cornell and seven at Parker have been converted to classrooms.

A. Information pertaining to the use for which the two rooms at Cornell and the seven rooms at Parker were designed is not available.

B. All classrooms in Bond, Burnside, Cornell, Dixon, Gregory, Kipling and Parker meet current fire and health standards.

C. There are no basement classrooms in Bond, Burnside, Cornell, Dixon, Gregory, Kipling and Parker.

7. Interrogatory: What room (type of room and location) does adjustment teacher use to conduct tests, etc.?

Answer: Objected to.

8. Interrogatory: Is there a special room for a library?

Answer: There is a special room for a library at Bond, Cornell, Gregory, Kipling and Parker. At Burnside and Dixon, there are library books in classrooms, books are circulated for home reading, and the teacher-librarian gives library instruction in the classroom.

9. Interrogatory: Are the children permitted:

- A. To take books home?
- B. To take library books home?

Answer: Pupils at the Bond, Burnside, Cornell, Dixon, Gregory, Kipling and Parker Schools are permitted to take both library and text books home.

10. Interrogatory: Is there a room designed for use as a lunch room?

Answer: There is an equipped lunchroom and a hot lunch is served at the Bond, Burnside, Cornell and Gregory Schools.

11. Interrogatory: If answer to No. 10 is NO, is there a make-shift lunch room, and if so, where is it located?

Answer: Sandwich lunch service at Dixon is provided in the assembly hall. Children at Parker may use the lunchroom in the neighboring Parker High School if they desire. There is no lunchroom at Kipling.

12. Interrogatory: Who supervises the lunch room?

Answer: Lunchrooms at Bond, Burnside, Cornell, Dixon, Gregory and Parker High are supervised by one or more teachers at all times.

13. Interrogatory: Number of teachers (assigned and substitute) in actual teaching positions (excluding master, adjustment, special service, library, special education, floating, and physical education teachers)?

14. Interrogatory: How many divisions are taught by assigned teachers?

21. Interrogatory: Is there a full or part time (indicate which):

- A. Psychologist
- B. Teacher Nurse
- C. Truant Officer

Answer: Objected to.

22. Interrogatory: What first aid facilities are available and who is responsible for same?

Answer: Objected to.

23. Interrogatory: How many Negro students?

Answer: Not known. Defendants make no record and never have of the number of Negro students at any school.

24. Interrogatory: How many white students?

Answer: Not known. Defendants make no record and never have of the number of "white" students at any school.

25. Interrogatory: How many students of other races?

Answer: Not known. Defendants make no record and never have of the number of students of any race in any school.

26. Interrogatory: Do Negro students attend classes with white students in all grades or only in certain grades?

Answer: Not known. Defendants make no record and never have of whether Negro students attend classes with "white" students in any grades at any school.
